

CONVEYANCING SCALE FEES PURCHASES & RETIREMENT VILLAGE LEASES

Our conveyancing fees are based on the value of the property transaction, which reflects the increased risks, the greater degree of professional responsibility and often the greater urgency involved in larger transactions.

The following scale applies to purchase of existing residential and commercial properties. <u>Additional fees apply to off-the-plan purchases</u> which usually involve more complex contracts and greater risk to the purchaser. We can only quote for off-the-plan purchases once we have seen the vendor's proposed contract.

In addition to the professional fees we charge as below, you will be required to reimburse us for any disbursements (e.g. title searches or city agent fees) that are incurred on your behalf. These usually range between \$550 and \$880. You will also need to reimburse us for any property investigation reports (eg. NSW PRE-PURCHASE building/pest report ~\$450 to \$800 or strata records search - \$300) that we arrange at your request. Review or witnessing of bank/loan documents is not covered by this fee and will be charged in addition depending on the time spent.
